**Rules and Regulations**

Students are granted admission to this institution with the specific understanding that they will abide by the rules and regulations of the school regarding discipline, uniform and attendance in classes as laid down by the management. In this regard they must strictly adhere to the following:

- I/We understand that for the purpose of uniformity in books, school uniform and other accessories and maintenance of its quality, the school may authorize dealers to provide these items to our wards and it will be obligatory on my/our part to take items from them.
- I/We agree that the school fees would be automatically linked with escalating costs and determined by the management of the school accordingly.
- I/We also undertake that in the event of default of school fee and/or any other dues, the management of the school reserves the right to take appropriate action as deemed fit.

- I/We will inform the school authorities about any change in my/our home address or telephone numbers immediately after the change for updating the records and will not hold the school responsible for not receiving the information.
- Indulging in agitational activities is a breach of undertaking/discipline. I/We will not cause or involve in any sort of annoyance, violence or disturbance of tranquility to vitiate the academic atmosphere of the institution.
- I/We as parents/guardian of the students are expected to extend our full cooperation to ensure maintenance of discipline.
- Every student aspiring for a rewarding career shall endeavour to make the school proud by excelling in studies and good manners, politeness, courtesy in speech and conduct as well as cleanliness.
- Any form of bullying or ragging will result in a disciplinary action as mandated by law.
- Any misbehaviour or violation of school discipline will be dealt by the disciplinary committee and corrective measures will be taken. In extreme cases parents will be called upon to discuss the child's behaviour and may lead to penal consequences as prescribed by law.
